## **ZAAC** Meeting Minutes

March 12, 2018

Financial balance was reported at \$29,147.61.

## **Committee reports:**

<u>Art in East Park</u> - Art in Z Park will be the unofficial title. Artists will be given an option to display their art on two days, Saturday and Sunday, June 16 and 17, choosing only one day if they prefer. Most activities such as children's art judging will continue to be on Saturday. Brenda was given the go-ahead to purchase two lighter folding tables for the festival and other uses for about \$160. New banners also will be ordered as the old ones are tattered and worn from long use.

Nilson moved, Smith seconded approval of the festival budget as presented, with an option to change the budget if necessary. Passed unanimously.

<u>Music in the Park</u> - Whitaker reported that grant information has been submitted. Concerts are in planning stages for June 12 to Aug.7, with no concert the week of July 4.

<u>Art on Main</u> - Plans are under way for 2018. Artists have been contacted and art will be selected in the next month.

**Art Splash** - Letters have gone out for 2018. The date will be Sept. 15.

<u>Building Project Update</u> - Tile work is complete and an opening is planned soon. Work continues.

<u>Theatre Management</u> - Reports were heard and the following motions were proposed and passed:

Smith moved, Whitaker  $2^{nd}$  to approve new fees as proposed by the Management Committee. Passed unanimously.

Smith moved, Burfeind  $2^{nd}$  to approve the theatre budget as proposed by the Management Committee. Passed unanimously.
